# MINUTES Meeting of April 3, 2014

## Officer's Report

Chair: Becky thanked everyone who helped at Thompson's Ravioli Feed; she will attend the NB Labor Council on Monday, April 7 for local candidate interviews at the El Grande. Insurance has been paid for the year – Democratic Club has paid; Stonewall Club is due.

Treasurer: James reported that the Dessert Auction netted \$345. Balance on hand is \$7,535.

#### **Standing Committee Reports**

Finance: James reported 29 new members toward the goal of 50 new members.

<u>Voter Registration</u>: Booth will be held at the Lower Lake Memorial Day event. A. Estuoki added to the Fair booth committee.

<u>Issues</u>: Ballot Measures: Shirley reported that the committee met on March 31 and made the following recommendations:

Yes on Measure L - Lake Measure for one-half cent tax.

Yes on the Statewide Health Initiative.

Issues committee voted to pull Measure N; await more acceptable plan.

Recommendations by the Committee were accepted. Discussion on No on Measure N to follow.

<u>No on Measure N</u>. Becky invited supervisorial candidates, club reps, legislative reps, guests and associate members to speak. Time allotted: 3 minutes to speak; and 3 minutes to read written statements by others.

Wanda Harris stated her objection to non-members and associate members having precedence in speaking over voting members and explained that non-voting members could only have the floor if no voting member wished to speak. She question giving six minutes to each attendee and inquired as to how those members with prepared statements to read were notified that that was acceptable and why all members were not also notified.

There was discussion and objection to reading written statements by others since no other committee members were notified that written statements by others (constituents) was allowable; objection was that only certain people in the meeting had written statements and they were being given allotted time to read them-- giving one person six minutes total.

Ron Green read a written statement; objection was raised when Ron tried an additional three minutes to speak. After discussion, Ron raised the following motion.

MOTION: It was moved by R. Green, and seconded, that each speaker be given three minutes to give an oral statement, and three minutes to read a written statement by others. Vote: Yes - 6; Nos - 9. Motion failed.

It was recommended by Peter Windrem that the Committee take no position on endorsing No on Measure N.

Wanda Harris moved that a roll call vote be taken (each member's name would be called and voice their vote verbally) and asked to speak to the motion.

MOTION: It was moved by W. Harris, and seconded, that a Roll Call vote be taken that the Committee take no position on the No on Measure N. Roll Call Vote: Yes -10; Nos -7; Abstentions -1. Motion was approved.
