# **Congress Member Mike Thompson**

Becky Curry (on behalf of Wally Holbrook) reported that:

- Napa Chamber of Commerce endorsed the permanent protection of Berryessa Snow Mountain Region.
- Announcing a Department of Health and Human Services Grant of more than \$939,000.00 for Lake Family Resource Center to be used for Early Head Start program.
- Introduced a Crude-by-Rail Safety Act.
- Bi-partisan call to end gun riders in appropriation bills.
- Sonoma County Fleet Operation selected as an EPA Clean Air Excellence award winner.
- Co-authored Social Security program tax cuts for seniors, increase benefits and strengthen program.
- Voted No on TPP fast track.
- \$3.7 m for Santa Rosa Community Health Centers.
- Elected Vice Chair of the Eisenhower Memorial Commission.

 Introduced medical marijuana bill SB 643 the Medical Marijuana Public Safety and Environmental Protection Act, which passed Senate Business and Economic Development Committee as well as Senate Governance and Finance, and is now sitting in Appropriations.

- SB 593 Thriving Communities and Sharing Economy Act, which regulates on-line vacation rental business and helps communities collect Transient Occupancy Taxes. The bill passed out of Senate Transportation and Housing Committee.
- SB 148, a \$600 million career technical education bill.
- Hosting a convention after-party w. Bill Dodd, for those going to the convention in Anaheim.

Chair Curry reported that:

- Lawrence Zackson, a member of the California delegation to the DNC, emailed her re. members only conference call which took place 5/5/15. Participants were briefed on the TPP fast track bill.
- Thanking everyone who baked and/or volunteered at the Ravioli Feed. We cleared \$478.00.
- Also thanking the people who volunteered at the Cinco de Mayo event in Lakeport (5/3/15) by staffing the voter registration booth.
- CDP Rural Caucus is working on "Payment in Lieu of Taxes", which is now sitting in Senate Appropriations.
- Becky will be at the Chair Workshop at the convention on Thursday. Fourwaters has asked her to be on the panel on the strategic planning process.
- Still meeting with Ed Robey, Victoria Brandon and Dennis Darling re. proposed Walmart expansion.

- Not too early to educate people on what the consequences would be should it pass.
   Recommend everyone talk to neighbors and friends about SoJ, start a dialogue in the community.
- A PAC (political action committee) has been formed. They are asking that we all sign the pledge form to endorse and support Keep it California.
- A PAC cannot take cash donations; donations have to be traceable.

#### **Voter Registration:**

- The Voter Registration Committee will be responsible for our participation at the Lake County Fair.

## On Going Business:

Strategic Plan tasks:

- Dave and Wanda had volunteered to call lapsed members. They were given a list of approximately 30 lapsed members to call (15 each). We don't know if any progress has been made on this to date.
- Carlos went to Yuba College to get the OK to form a Young Democrats Club. He will give a presentation to the student body which has to approve all new clubs.

- 2015 BBQ time line and volunteer assignments list handed out: Becky is currently looking for leads for the various tasks. Once leadership has been assigned, other volunteers will be recruited.
  - 1) Leads have been assigned for the following tasks: barbeque, letters to the legislative sponsors, keynote speaker, drinks table, reception table, graphics and printing, music, silent auction, Mike Thompson's flag raffle, securing the senior center.
  - 2) We still need a lead for the following: side dishes/meal service, soliciting business sponsors and soliciting silent auction donations/pick-up & delivery.
  - 3) This year we are seeking additional business sponsors who would be recognized at the BBQ as well as in the program.
  - 4) Please start thinking about in what capacity you would like to volunteer. Sign-up sheet will be passed around next month.
  - 5) Attendance goals for the BBQ were exceeded in 2013 (150 attendees) because everyone committed to bringing new people to the event. To be able to afford a campaign office in 2016 and send campaign mailers we need to increase revenue from the BBQ. If everyone brought two new people with them, we could meet our goals.
  - 6) Further discussion and updates on the BBQ assignments to follow at future meetings.
