Treasurer James Evans reported:

General Fund:

- Received \$303.00 from Lake County Democratic Club towards storage shed payment
- \$500.00 BBQ sponsorship from Sen. Mike McGuire
- Paid \$30.00 for Voter Registration booths at HVL Concerts on the Green June & Sept
- Paid \$25.00 Deposit for Clearlake Senior Center rental for annual BBQ
- Over budget \$15.00 for Voter Registration and \$105.00 for storage unit
- Balance on hand \$1139.00

Budget:

There have been three alterations to the budget. We will no longer receive \$217.00 from the Stonewall Club for insurance. They will obtain their own policy. The Stonewall Club has also opted out of sharing the cost of the storage unit and the Lake County Democratic Club has agreed to pay for half the cost and the DPLC will pay half the cost rather than a third.

The storage facility has also raised our rent from \$500.00 to \$605.00 annually. We will pay \$303.00 instead of the \$167 we paid last year, or \$ 136.00 more. The total negative impact to the budget form these changes is \$353.00
