<u>Guest Speaker:</u> Don Saylor, running for the open seat in the 4th Assembly District (Bill Dodd's seat). Don introduced himself and his platform: environment, health care, women's health, broadband as part of the infrastructure. Also running for this seat: Cecilia Aguilar-Curry of Winters, Dan Wolk of Davis and Charlie Schaupp(R) of Esparto.

#### **Legislator's Reports:**

Congress Member Mike Thompson Representative Holbrook (absent)Becky presented report.

- U.S. Rep. Mike Thompson supports the Iran Nuclear Agreement and issued a statement on that.
- Announced that USPS has agreed to stop pursuing the demolition of the historic downtown Napa post office.
- U.S. Rep. Mike Thompson and Congressman Garamendi announced a \$2 million FEMA grant for Rocky Fire victims.
- Mike Thompson secured more than\$2 milling for American Canyon Green Island Industrial District.
- Over \$176,000 for Affordable Care Act funds for Santa Rosa Community Health Centers.

- Legislature is now in session. 9/11 is the deadline to submit legislation to Gov. Brown's desk.
- Sen. McGuire's Medical Marijuana legislation is still advancing, but will most likely be tacked on to Assemblyman Banta's bill.

- Coastal Protection Act of 2015 which would ban all offshore oil drilling off the California coast has been held in committee. McGuire will bring that back in 2016.
- Legislation supporting mobile home owners and protecting redwood burl poaching have advanced to the Governor's desk.
