#### **Public Comment:**

- Ron Green introduced Cheryl McGinnis Johnston D-1 Board of Supervisor candidate who will be the speaker at the January central committee meeting.
- Cheryl McGinnis Johnston gave a brief introductory statement.

- Monica Rosenthal, Candidate D-1 BoS, had an update on the formation of the county's long term recovery task force, as well as the communities' effort titled Team Lake County.
- Victoria Brandon announced there will be a group forming to address re-forestation and erosion control and resources available for sustainable environmental recovery.
- Steve Greenberg announced there will be a Team Lake County meeting tomorrow 10:00 am (11/6) at Twin Pines Casino.
- Larry Barron suggested Lake County should utilize goats and sheep for weed abating after the wild fire.

<u>Guest Speakers:</u> Victoria Brandon and Ed Robey gave an update on the proposed Walmart expansion.

- Walmart has completed their application for expansion of their Clearlake super store.
- There will be a complete Environmental Impact Report (EIR),
- They expect there to be archeological remains due to the proximity to Anderson Marsh.
- CEQA report will show expected impact on community and businesses.
- There are also labor issues with the planned expansion.

#### **Legislator's Reports:**

<u>Congress Member Mike Thompson Representative Holbrook reported:</u>

- Congressman Thompson announced \$258,000 for Sonoma Valley Community Health Center.
- Housing grant \$279,467 for Napa Valley Fair Housing Center.
- Mike Thompson stated that congressional republicans have failed to act on any common sense legislation addressing mass shootings. There have been no votes or proposals.

- He announced a \$2.6 million grant for Napa Valley College; they qualify due to their >25%
  Hispanic student enrollment. Yuba College Clearlake campus, as well as Mendocino College,
  have already received monies.
- USPS has listed downtown Napa Franklin Station post office for sale. The historic building will
  not be demolished.
- Mr. Thompson introduced a resolution to establish a select committee of the House (6 Republicans and 6 Democrats) on gun violence.
- Announcing a \$1.5 million grant from the Department of Defense for riptide bioscience, to help continue the research that is happening on Mare Island.
- Announcing that public assistance / FEMA funds for people impacted by the Valley Fire are being fully utilized for future fire suppression, rebuilding homes and businesses.
- Treasury will allow BRAC sites (like Mare Island) to more easily qualify for economic development tax credits.
- Rep. Thompson voted to pass bi-partisan debt ceiling agreement to keep government open.

- Senator McGuire continues to deal with the aftermath of the fires and has worked closely with Redwood Credit Union and the Press Democrat to raise over \$2 million for the relief effort. People needing assistance should contact his Santa Rosa office.

- Legislative session closed in September. Many of McGuire's bills were signed into law:
  - ✓ Money secured for career and technical education in middle and high schools.
  - ✓ Money for rural school bus safety and upgrades.
  - ✓ Comprehensive medical marijuana regulation legislation.
  - ✓ Several priority bills that he co-authored were signed into law by Governor Brown: Low Income Water Rate Assistance program, Equal Pay Act, End-of-Life Options Act.
