- Rep. Thompson dedicated Berryessa Snow Mountain National Monument.
- On March 8th Rep. Thompson hosted an educational forum on substance abuse and dangers of self-medication.
- On March 30th Rep. Thompson hosted discussion on legislation to improve and protect social security with seniors from the ^{5TH} district.
- On March 24th Rep. Mike Thompson spoke on rail safety during the final day of the 3-day Railroad Hazardous Materials Awareness Training.

- Planned Parenthood news:
 - o PP endorsed Hillary for president.
 - Birth control over the counter without prescription (SB 443) just passed.
 - Multiple actions on women's health: 48 bills to limit access, 19 votes to restrict access, 7 votes to defund PP, etc.
 - Parental notification initiative fizzled out and won't be on the ballot this time due to lack of signatures.

Treasurer Evans:

- General Fund:
 - \$105 in dues received in March
 - \$500 sponsorship from Mike McGuire
 - \$25 from CLDC for re-charter of Club
 - \$650 spent on insurance
 - \$450 on convention reimbursements
 - \$259 for event center rental balance due and \$500 for refundable cleaning deposit
 - \$100 for Concerts on the Green for 6 month event series
 - Our balance on hand is \$3,530.

Budget:

- 1st quarter \$3,042 short due to not having received the check from the Stonewall Club disbandment yet. A check in the amount of \$3,402was just now delivered. It will go on the 2nd quarter books.
- o \$270 and 18 memberships short of what was budgeted dues/donations goal.

- \$375 over budget expense due to the Middletown Mansion rental and deposit (budgeted in the 2nd quarter).
- \$292 under budget for convention reimbursements. Two attendees decided not to submit for reimbursement.
- o Received \$1,000 in sponsor donations for the candidate event.
- Spent \$1,000 for event venue rent and cleaning deposit.
