 - These nominees will be asked to address the committee at the January meeting and the voting membership will vote on whether or not to approve their appointment.
- 2. California Democratic Party delegate elections
 - The Lake County Democratic Party is entitled to elect 6 members from the Committee to serve as delegates to the State Party conventions. One of those members will be the County Party's executive board representative. Delegates serve for two years (2017/2018) Voting members of the County Party will elect delegates at the January 5, 2017 meeting.

 - Assembly District Delegates Each of California's 80 Assembly Districts will elect 14 delegates (7 men/7 women). Assembly District 4 elections will be held on January 8 in Davis at Mary Stephens Library 315 E. 14th St in Davis from 1pm-4pm.
 - Delegates appointed by Legislators Each of our Congressmembers, our Assembly member and our State Senator representing Lake County are entitled to appoint delegates to the State Party Convention. Please contact one of them if you wish to be considered for an appointment.
