# Legislator's Reports

Congress Member Thompson – Alternate M. Friel

- Mike held a series of **Healthcare Town Halls** across the district to get the community's thoughts on the GOP's plan to gut the Affordable Care Act. He has held events in Vallejo, Martinez, Napa, and Santa Rosa—the last of which drew a capacity crowd of more than 2,000 constituents. Mike is taking your concerns and stories back to Washington as he prepares to fight for the ACA on the Health Subcommittee.
- With Congress and the country still reeling from the President's Muslim ban, Mike cosponsored two bills to protect
  immigrants' rights. The **Dreamers, Immigrants, and Refugees (DIRe) Legal Aid Act** would provide help to the most
  vulnerable among us so they can receive legal assistance should they face detention or deportation. The **Build Bridges**Not Walls Act would block the President's costly, ineffective, and insulting border wall.
- In the wake of the allegations around Michael Flynn and his subsequent resignation, Mike called for an independent investigation into the administration's ties to Russia.
- With Women's History Month right around the corner, Mike began accepting nominations for his annual **Woman of the Year Awards**, recognizing exception leaders in business, public service, philanthropy, and other sectors. The winners will be announced this month at a special ceremony.
- At the urging of local law enforcement officers from our community, Mike led a group of lawmakers in calling on ICE to
  remove the word "POLICE" from its gear. By misidentifying themselves as police officers, ICE risks undermining the
  relationships between local law enforcement and immigrant communities. This puts everyone at risk, as crimes could go
  unreported for fear a victim or their loved one may be deported.
- As Chairman of the Gun Violence Prevention Task Force, Mike urged his colleagues to bring law enforcement officers as
  their guests to the President's Address to a Joint Session. Together they held a press conference on Republican
  Proposals to Undermine Public Safety—raising much-needed awareness on the GOP's attempts to deregulate silencers
  and weaken concealed carry permitting procedures.
- Mike also launched "Adopt a District" to help elect Democrats in swing districts. He'll host two fundraisers for Jon Ossoff in the GA-06 race on March 24<sup>th</sup>—one in Sonoma and one in Napa.

# Additional questions/concerns from DCC for Congr Thompson:

- D.Boivin requested Thompson respond to concerns of what is being done to protect immigrants from deportation in our area.
- S.Cameron asked Thompson to provide information on sanctuary networks
- > J.Holt reported that local school superintendent says LC schools will not keep immigration records on students; the group felt this information needs to be widely disseminated, so students will feel safe attending school.

Congress Member John Garamendi – Alternate S.Harris not present, B.Curry gave report:

- Sissa Nelson-Harris has been appointed as the Congressman's alternate to the Committee.
- The Congressman has been busy assisting constituents in the aftermath of the Oroville Dam flooding.
- The Congressman has opened nominations for his annual Woman of the Year award. Deadline to submit applications is August 17,2017. The Committee will make an effort to provide him with some nominees from Lake County.

- Update on SB 149 Pres Tax Transparency the Senator is asking for online petition signatures for support. That will be emailed out under the Dem email address for people to sign/posted on our facebook page & our website
- McGuire was at an ACA Townhall w/Congr. Thompson on Feb 25 in Sonoma County.
- The Senator reiterated his support for SB 562 (Lara) in support of Single Payer Health Care in California
- The Senator also hosted a Town Hall in Middletown addressing issues around the rebuilding efforts in the wake of the Valley Fire.

Assembly Member Cecilia Aguiar-Curry - Alternate Lenny Matthews not present, B.Curry gave report:

#### AB401 - TELEPHARMACY

People living in pharmacy-deprived areas, both rural and urban, face many barriers to obtaining comprehensive medical care. These patients desire more convenient access to their health care services, and remote pharmacy dispensing is a proven model to provide improved care that is both safe and effective.

Under existing law, prescription drugs can only be dispensed by a licensed pharmacy and pharmacist. There is no current authorization for licenses to be issued to remote dispensing pharmacies, and no existing use of telepharmacy communication services in California. AB 401 creates a state license for remote dispensing pharmacies. The Board of Pharmacy will issue these licenses and determine the pharmacy-deprived locations eligible for a remote dispensing pharmacy.

AB 707 – Blue Ribbon Committee for the Rehabilitation of Clear Lake AB 707 would establish a Blue Ribbon Committee for the Rehabilitation of Clear Lake, housed within the Natural Resources Agency. By working towards improving the environmental quality of the lake, this bill will benefit Lake County as a first step in helping the local economy through promoting

AB 273 - "Unlocking Opportunities for Families" - Subsidized Child Care Eligibility Criteria In order to be eligible for state subsidized child care, families are required to meet eligibility requirements for income and need. AB 273 would add ESL and HSE educational programs to the list of eligibility criteria for state subsidized child development services under the California Educational Code.
